WDC New Local Plan – Responses to the consultation are now closed. WDC will provide further information next year.

Proposed extension of speed limit Clay Common -No progress

Latitude feedback — The general feeling is that the new traffic plan worked well, although some AA signs have not yet been collected from the roadsides. There was some disappointment that the pedestrian/cycle entrance was not provided, it seems Festival Republic would rather locals used the buses laid on for the event. D Cllr Rivett said that the weekend challenged the police on their Speedwatch activities as the police presence was far too low.

Frostenden's Latitude Ticket money. The Frostenden Councillors held an informal meeting to discuss how to spend the money (£1600.00 for 2 years) on the village and came up with the following: £300 each to the Village Hall & the Playing Field and £1,000.00 for a party for residents which, as this is not public money raised by Council Tax, is legal.
