

## **FROSTENDEN UGGESHALL AND SOUTH COVE GROUP PARISH COUNCIL**

### **Draft Minutes of the Zoom Virtual meeting of the Parish Council - TUESDAY 3<sup>rd</sup> November 2020 at 7.30pm.**

**Present:** Chair Cllr Hall, Cllrs Burton, Sanger, Watson & Goldson.  
Attending, Clerk J Brown & 1 member of the public.

Cllr Hall proposed Cllr Goldson give his report now as he is due to attend another meeting shortly, aif.

**Cllr Goldson** is still trying to get the 50mph limit along the length of the dual carriageway at Wangford, he has received complaints from some motorists who feel it should revert to 60mph from Wrentham to Wangford.

All Council car parks in the District are now free for 30mins and short stay is now cheaper than before. Covid cases are rising in Suffolk and Norfolk, and 107 beds were out of use at JPH yesterday due to infections. Cllr Goldson asked that anyone who needs help due to Covid get in touch as SCC have various schemes in place to help with getting food, medicines etc during the new lockdown period. The volunteer schemes for Uggeshall (Sarah Butt) and Frostenden & South Cove (via VHC Southwold) are still operating as before. Cllr Watson thanked him for his help with the A12 speed limit but said that the signage is inadequate, wrongly placed and some are obscured by other signs, however the owner of Wangford Service Station said he had noticed a change in speed along that stretch of road. Cllr Goldson will look into the signs and is happy to hold his 'Parishes Meetings' via Zoom if there is enough interest.

Following the ANPR camera trials in Spexhall SCC will be investing in them, evidence provided by these cameras can result in prosecution for repeat offenders. The PC are interested in joining with the Parishes group shared speed camera for Clay Common. Cllr Burton asked what is being done about the continued flooding of Potters Bridge in Reydon which results in a considerable amount of extra traffic diverting through Frostenden Corner to get to Southwold & Reydon. Cllr Michael Ladd has been working towards a long-term solution to this and the Environment Agency are looking at the problem seriously now.

Clerk to write to Highways to ask if the No Through Road sign at Frostenden Corner triangle could be moved around or replaced with a bigger one as it is presently obscured by other signs.

There has been no reply from Highways to the Clerk’s request for a price for the sign requested by Cllr Watson, the Clerk to ask if CIL can be spent on one.
