Safe reopening of village halls and play areas. The Clerk has forwarded Gov & insurance companies' guidance to reps of Frostenden Playing Field Committee, Frostenden Village Hall Committee and Cllr Hall who will send onto to Giles Crisp for Uggeshall Church Rooms.

Cllr Burton asked if the owner of the Golf can be asked to move it away from the Village Hall gates, Waveney Norse have established it has not been abandoned. Clerk to write.

Cllr Burton would like to advertise the existence of Frostenden's Parochial Charity, the Clerk will put it on the website, Cllr Sanger suggested posters in the shop and GP Surgery.
