Cllr Fairhead has not attended a meeting since September 2018, the Clerk is to write to ask if he still wishes to represent Uggeshall on the PC.

PUBLIC FORUM –to include REPORT/COUNTY & DISTRICT COUNCILLOR'S REPORTS and Crime Report sourced from Suffolk Constabulary's website -

Cllr Goldson is to put all his budget of £28,000 to his Parishes. If the PC vote refusal to a planning application on planning law grounds let him know and he will put forward their views to ESC's Planning Committee, he also advised that the PC could ask for plans to be discussed by them. He is still arguing the case to make the whole Wangford bypass 50mph for safety reasons. The meeting agreed that the Police Road Safety Team are very inconsistent. Cllr Brooks will hopefully be back in the New Year. The Clerk should ask Highways for double white (no overtaking) lines on the A12 from the Clay Common turn off to Church Lane.

Crime report: There were no crimes reported in July. August: 1 x other crime & 1 x other theft Kiln Road – both under investigation. September: 1 x vehicle crime Kiln Road – awaiting court outcome.
